Dear Friends & Fellow Patriots,

Many thanks to all who attended our meeting and a hearty welcome to all the new members of Free PA.

SUMMARY OF EVENTS/CALLS TO ACTION:

General Chapter Business:

- Our Free Pa Family was proud to host two candidates who had announced their run for office at our gathering. Ann Weston has announced her run for the 100th State House seat challenging Bryan Cutler and Mike Miller will be running for the seat in the 36th District that is now held by Ryan Aument.
- Mike Miller is a local business-man, husband and father whose family ties to Lancaster County go back to the colonial days. Mike spoke out with Lancaster for Free & Fair Elections in the fall of 2020, contesting the certification of the electors. Part of the group that pressured lawmakers to decertify the PA election, Mike had a chance to meet with President Trump and develop ties with his team. Mike has worked with Free PA all throughout 2021 in assisting parents to organize and reclaim their school boards, remove CRT and end masking mandates. - In conjunction with a national effort begun in cooperation with Dr. David Martin and the Constitutional Law Group, indictments against Fauci, Daszak, pharmaceutical companies and others were filed with every state attorney prosecutor and 300 county

prosecutors throughout the nation, including Heather Adams here in Lancaster County. In addition, the prosecutor was given a 250-page dossier exposing the crimes committed against citizens in the county as a result of denial of early treatment, murderous hospital protocols, the violation of patient's rights, including the right to try. We will seek punitive damages against the bonds of the prosecutors if they fail to do their duty and investigate. We will keep you updated on this effort.

- Free Pa also met with Representative Smucker to inform him of the Covid abuses by hospitals, the persecution of doctors and nurses who seek to practice early treatment and the refusal of pharmacies to fill valid prescriptions for Hydroxychloroquine and Ivermectin. We discussed the lack of informed consent and the growing body of evidence that the vaccines are harmful and potentially deadly. Free Pa expressed the dissatisfaction of our membership on his vote for HB 550 and challenged his narrative that the bill was “a protection against a bi-directional vaccine database”. We are to meet again with him before he joins us for a town hall on April 14th.
- Our new website will be ready to within one week! We are excited about it and cannot wait to share!
- Free PA will be attending the Remember America Event, sponsored by Dayspring Academy. They are anxious to partner with us and, as such, will be speaking at our chapter meeting on March 24th. This year's Event will be held at the Marriott Convention Center on Saturday April 23, 2022 and the keynote speaker will be Charlie Kirk. The event begins at 6:00pm. You may purchase tickets to the event at the meeting on 3/24. Free PA will have a table in the lobby of the event to reach out to our Lancaster community and extend an invite to join us at our meetings and in our mission.

State Matters:

We are gearing up for the coming elections! We need your help! [A google document will be sent out separately soon.](#) Please complete the information so that we can reach out to you for election help in your district. The only way to win back our local government is to band together with boots on the ground to elect people who actually represent us. Additionally, please contact your local GOP council lead and ask to be appointed to an open GOP seat if it exists in your precinct. There are 185 open seats throughout the county. These committee members are tasked with choosing which candidates the party eventually endorses. We must control the majority of these seats to kick the RINOs out. National Matters:

1. The US Senate is poised to vote on HR 3755 on February 28th. Senate Majority Leader Chuck Schumer says the Women's Health Protection Act would declare “a woman's right to choose is fundamental right.” The bill passed the US House in September by a vote of 218-211 with all Republicans and one Democrat voting against it. If passed this bill would eliminate modest and widely supported pro-life laws at every level of government — the federal, state, and local level — including parental notification for minor girls, informed consent, and health or safety protections specific to abortion facilities. It would force all Americans

to support abortions here and abroad with their tax dollars. It would also likely force health care providers and professionals to perform, assist in, and/or refer for abortion against their deeply-held beliefs, as well as force employers and insurers to cover or pay for abortion. **This must not pass in the US Senate!**

2. The Biden Administration has quietly extended the national Covid emergency declaration despite most states are dropping all restrictions. As a result, we are stuck with federal mask mandates and other violations of our constitutional rights. Texas is currently challenging the travel mask mandates in federal court.
3. The Biden administration had made the move to freeze all new federal oil and gas leases; the action was challenged by a LA federal court that maintained that the metric used for calculating greenhouse gas emissions was not permissible. Facing that challenge in addition to the outbreak of war in the Ukraine, the Biden administration walked back the suspensions. Under President Trump, the US was energy self-sufficient for the first time since the 1940s. The Biden administration has destroyed those gains. The US obtains its petroleum from Canada, Mexico and Russia, in that order, at the current time.
4. **NOMINEE TO SUPREME COURT:** The Biden administration has been very predictable in appointing the most radical, Marxist, leftists to all levels of government. Frontrunner to the Supreme Court Judge **Ketanji Brown Jackson** has been officially named as the nominee. Jackson was an active and dedicated advocate for terror suspects housed at Guantanamo Bay, contrary to press accounts and her own representation. Her advocacy was zealous and often resembled ideological cause lawyering, even in her capacity as a public defender. At times, she flirted with unsubstantiated left-wing theories that were debunked by government investigators. On other occasions, she accused Justice Department lawyers of egregious misconduct with little evidence
5. **NOMINEES FOR FEDERAL RESERVE:** Oppose the Biden nominees who will work to destroy our fossil fuel industry and impose an ESG system using Federal monetary policy. They include: Sarah Bloom-Raskin, Lisa Cook & Philip Jefferson.

ACTION: CONTACT YOUR SENATORS!

Free PA is sounding the alarm on ESG and the negative impact this social credit system will have on our economy and our freedoms. ESG means using Environmental, Social and Governance factors to evaluate companies and countries on how far advanced they are with sustainability. Once enough data has been acquired on these three metrics, they can be integrated into the investment process when deciding what equities or bonds to buy.

ESG factors: Environmental

Environmental factors include the contribution a company or government makes to climate change through greenhouse gas emissions, along with waste management and energy efficiency. Given renewed efforts to combat global warming, cutting emissions and decarbonizing is become more important.

ESG factors: Social

Social include human rights, labor standards in the supply chain, any exposure to illegal child labor, and more routine issues such as adherence to workplace health and safety. A social score also rises if a company is well integrated with its local community and therefore has a 'social license' to operate with consent.

ESG factors: Governance

Governance refers to a "stakeholder capitalism" which entails corporate cooperation with the state and vastly increased government intervention into the economy.

Covid Updates:

1. The CDC caught red-handed holding back data in the 18-49 age group on vaccines. There is speculation that the data is not favorable as to the efficacy or effectiveness of the vaccines.
2. In Supreme Court justices on Feb. 22 rejected a bid by health care workers in [Maine](#) to block the state's COVID-19 vaccine [mandate](#).
3. Despite Novavax's public statements that its COVID-19 vaccine does not have any connection to abortion, evidence from a private letter and Novavax's own published study shows that the HEK293 aborted fetal cell line was used in the testing phase.
4. Various media and mainstream print venues have begun a new narrative citing new research published in the journal Nature Medicine that has found that people with COVID-19 may be at "substantial" risk of [heart complications](#) for at least one year following testing positive. The heart complications can include blood clots, irregular heart rhythm, inflammation, heart attack, and heart failure, that in some cases, resulted in death. The problem with these studies is that the 'science' did not evaluate Covid-recovered on the basis of vaccinated v. unvaccinated. Perhaps the long term effects of the spike protein in Covid are resultant from the MRNA vaccines as opposed to the natural virus???
