SUMMARY OF EVENTS/CALLS TO ACTION:

General Chapter Business:

- Please reach out to us if you have raffle items to donate or wish to volunteer. We need your skills!
- The construction of the site was delayed about a week, and we are hoping our new website will be ready by the third week of March. We are excited about it and cannot wait to share!

Education & School Boards:

Free PA has a new school board coordinator, Dina Agadis. She will be reaching out to

all district leads to begin to build a network of communication and action.

State Matters:

We are gearing up for the coming elections! We need your help! **A google document will be sent out separately soon.** Please complete the information so that we can reach out to you for election help in your district. The only way to win back our local government is to band together with boots on the ground to elect people who actually represent us. Additionally, please contact your local GOP council lead and ask to be appointed to an open GOP seat if it exists in your precinct. There are 185 open seats throughout the county. These

committee members are tasked with choosing which candidates the party eventually endorses. We must control the majority of these seats to kick the RINOs out.

Free PA is also asking you to support **HB2013: Right to Medical Freedom Bill.**

The petition states: *The right of an individual to refuse any medical procedure, treatment, injection, vaccine, or prophylactic may not be questioned or interfered with in any manner. Equality of rights under the law shall not be denied or abridged to any person!*

State Senators Doug Mastriano and Scott Hutchinson have a co-sponsor memo circulating for the **PA Energy Independence Act.**

The proposed bill asks for several things including an Immediate suspension of the Corporate Net Income Tax and Personal Income Tax for natural gas producers; exempt PA from certain EPA regulations such as the Cross State Air Pollution Rule; require a report from the DEP of all rules and regulations which impact PA's natural gas and oil industries; an immediate suspension of PA's entrance into the Regional Greenhouse Gas Initiative.

CALL TO ACTION: CALL & WRITE YOUR REPS & ASK THEM TO SUPPORT THIS

National Legislation:

1. Sens. Bill Hagerty (R-TN) and Josh Hawley (R-MO) have [introduced](#) the American [Energy Independence Act of 2022](#). In a joint statement, they said the bill's purpose is to reverse Joe Biden's "shutdown of the American energy sector" and allow domestic energy production to return to the total capacity.
2. **NOMINEE TO SUPREME COURT:** The Biden administration has been very predictable in appointing the most radical, Marxist, leftists to all levels of government. Frontrunner to the Supreme Court Judge **Ketanji Brown Jackson** has been officially named as the nominee. Jackson was an active and dedicated advocate for terror suspects housed at Guantanamo Bay, contrary to press accounts and her own representation. She was an author of a paper arguing that our judicial system is "unfair" to sexual predators; Judge Jackson significantly lowered sentences for child predators. Brown Jackson has repeatedly embraced supporters of Critical Race Theory (CRT) in past lectures and

speeches. She also called a journalist “irredeemably evil” for criticizing open borders! ! Most concerning however is the role of [Demand Justice](#), a left-wing legal group founded by former Hillary Clinton aide Brian Fallon under the financial sponsorship of liberal megadonor Arabella Advisors, in her nomination. Demand Justice included Jackson on its Supreme Court shortlist for Biden. The group has also advocated for court-packing to advance Democratic policies on the court.

3. **NOMINEES FOR FEDERAL RESERVE: [VICTORY!](#) Sarah Bloom Raskin’s nomination was successfully opposed, and she has withdrawn from consideration! CONTINUE TO OPPOSE** the Biden nominees who will work to destroy our fossil fuel industry and impose an ESG system using Federal monetary policy. They include Lisa Cook & Philip Jefferson.

CALL TO ACTION: CONTACT YOUR SENATORS!

4. **COVID Task Force Update:** This week, President Joe Biden named Brown University School of Public Health dean and ardent vaccine passport advocate Dr. Ashish Jha as the new White House COVID-19 Response Coordinator. *The National Pulse* has [identified](#) numerous such statements, starting with an April 2021 op-ed in which he argued for making restoration of “everyone’s full participation in society” contingent on “vaccine certificates,” dismissing concerns about the implications for personal freedom as “nonsense.” For support, he favorably cited the example of Israel’s Green Pass, the effectiveness of which has [since been panned](#), leading to its [removal as of this March](#).
5. **Climate Lockdowns Looming?** The International Energy Agency (IEA) has issued a new emergency plan on how nations might use less oil amid the supply shortage caused by the war in Ukraine. Their new *10-Point Plan to Cut Oil Use* looks to lower the demand for oil by 2.7 million barrels per day within four months. The United States is among the IEA’s 31 member countries. The new *10-Point Plan* comes on the heels of their 2021 report that offered certain “behavioral changes” the world should embrace in order to help reduce carbon emissions to net zero by 2050. Actions and restrictions called for include:
1. Lower speed limits by 6 mph
 2. Work from home 3 days per week
 3. Alternative use days for cars- odd/even
 4. Car sharing

6. **CALL TO ACTION: Call your senators and reps and demand that the US pull out of these globalist UN treaties!**

7. **JAN 6th:** A federal judge has dismissed a felony obstruction charge alleging a participant in Jan. 6 Capitol riot attempted to prevent the certification of the 2020 Electoral College results.

The ruling Tuesday by U.S. District Judge for the D.C. Circuit Carl J. Nichols, a Trump administration appointee, marks the second time in eight days the judge has issued such a dismissal.

CALL TO ACTION: Call your reps and demand that they end this political theatre now!

8. **TRUCKER PROTEST:**

There have been some very significant developments this past week and the DC establishment showed its ugly, tyrannical head 🐼

Starting on Tuesday, 3/15, the police started blocking all the exit ramps on route 295 to try to keep the convoy from entering the capital area and caused major safety related problems and mass confusion throughout the public, which caused major traffic jams each day.

On Friday, 3/18 they started running the exit ramps as checkpoints only allowing vehicles off the highway that appeared to have no affiliation with the People's Convoy (aka American Flags displayed on their vehicle)!!!

By closing all exits they are corralling the convoy to go in the direction the establishment has planned and this ensures that no one can turn around and try to enter the city from a different angle.

There have been attacks on these streets by BLM/Antifa throwing nails and rocks at the convoy!

The problem here is the Emergency Powers Act enacted in 2020. This is what this convoy is all about—calling for the abolition of that. Until rescinded, the government can reimpose mandates at their discretion and with even more restrictions than before.

CALL TO ACTION: Call your reps and senators and demand that they call for an end to these powers and the media blackout of this important protest!

Medical Freedom:

Pilots with major airlines JetBlue, American Airlines, and Southwest filed a lawsuit against the Centers for Disease Control and Prevention (CDC) and the Department of

Health and Human Services after the government again extended the airport and airline mask mandate. The CDC acted “without providing public notice or soliciting comment,” the lawsuit complained. “This mandate also raises serious constitutional concerns.”

ICAN is also suing the Federal Government over transportation mask mandates. ICAN has also successfully blocked the attempt by the DC government to circumvent parental rights in the vaccination of minors. **Minors aged 11 and up in the nation’s capital are temporarily no longer eligible to receive vaccines without parental knowledge or consent after a federal court for the District of Columbia granted a preliminary injunction against Washington, D.C.’s Minor Consent for Vaccination Act (MCA) on March 18.**
